CONSUMERS CAUTIONED AGAINST USING COSMETIC PRODUCT CONTAINING SCHEDULED POISON

The public is advised to avoid buying and using the following cosmetic products:

The cosmetic products as mentioned above have been tested and detected to contain scheduled poisons **tretinoin** and **mercury**. Out of the eight (8) products above, seven (7) products were previously notified with the Ministry of health (MOH), but the notifications have expired as stated in the list above. The notification for product Bio-Clear Intensive Renewal Complex has been cancelled by the MOH on the 8 October 2012. All mentioned products as above are no longer allowed to be sold in Malaysia.

The usage of tretinoin and mercury in cosmetic products are prohibited. Preparations containing tretinoin should only be used under the supervision of healthcare

professionals. The unsupervised usage of tretinoin can cause redness to the skin, peeling, discomfort and skin becomes sensitive to sunlight.

Mercury compounds are readily absorbed through the skin on topical application and tend to accumulate in the body. Direct and prolonged exposure to mercury can cause damage to the brain, nervous system and kidneys. Using products containing mercury can also result in skin rashes, irritation and other changes to the skin.

Companies responsible for placing the products in the market have been instructed to immediately halt the sales and supplies of the products mentioned and remove all physical stocks from the market within 72 hours.

Anyone who is in possession of these products is advised to immediately cease selling/distributing/using it. Sellers are reminded that <u>possession</u> of these products is an offence under the Control of Drugs and Cosmetics Regulations 1984. Any individual who commits an offence under these Regulations can be fined up to a maximum of RM25,000 or to imprisonment for a term not exceeding 3 years or both, and for a second or subsequent offence he shall be liable on conviction to a fine not exceeding RM50,00 or to imprisonment for a term not exceeding 5 years or to both. A company found guilty can be fined up to RM50,000 for the first offence and fine up to a maximum of RM100,000 for a subsequent offence.
